CDC Consultant Whitaker Wright was present for the first Public Hearing of 2023, and to discuss the eligible programs. They are limiting the county to two bigger projects for the year, instead of multiple smaller ones. Mr. Wright defined many of the programs, such as the Neighborhood Revitalization Grant, Critical Infrastructure, Economic Development, Residential Public Infrastructure (water & sewer only), as well as the CDBG Discretionary program, which he stated would require a big match.

There were no bids submitted regarding the PY2021 CDBG Bridge Replacement Street Improvement Project. Mr. Wright stated he would follow up with Engineer Miller and contractors. The estimate was \$100,300.00, but Mr. Wright said the challenge was getting steel quote pricing locked in before delivery.
