**Job & Family Services Director Tammy Osborne -Smith** made the following public announcements: The Health & Human Services at the Federal level extended the Health Emergency services for another 90 days, which would be October 15, 2022, but may be extended one more time after that date. This includes the Snap, Supplemental Nutritional Assistance, Food Assistance and Medicaid programs. Those affected are receiving more assistance under this extended health emergency. Director Osborne-Smith presented a letter from the Ohio Department of Job & Family Services stating they are making \$15 million in grant funding available to assist in one area of need – Children Services (recruitment & retention)-to help agencies develop successful programs to grow and maintain their workforce. Jackson County will end up getting around \$59,000.00 for every recruitment/retention. JFS continue to work with 15 other counties to improve their culture safety, which is to keep JFS staff safe, which includes the staff carrying fobs for field work(which is similar to life-alert).
