Ohio Public Defender Joe Medici and Chase Carter, as well as Juvenile Judge Justin Skaggs and Auditor Tiffany Ridgeway were present to discuss Ohio Public Defender matters. Mr. Medici stated this has been one of the most interesting state budgets he has been a part of. CCAO is wanting to add a little more than \$40 million to the overall budget for the next two years in the hopes of pushing the reimbursement rate up as much as they can. There are many scenarios to what will be part of the Senate bill, but nothing definite. Juvenile Judge Justin Skaggs stated that he and his staff have taken extra steps to eliminate the problem that has been an issue for a long time regarding attorney fees not being reimbursed by the state for various reasons, and he personally thanked Tommie Harless for working with he and Suzi in identifying and addressing the issues before hand. Judge Skaggs also requested that the Commissioners increase the attorney "out of court" fees from \$60.00 to \$75.00, to mirror what the in-court fees are. He is hoping this will keep attorneys working in this area instead of going where the money is better. The Commissioners requested some budgetary information to review before making a decision.
