The Commissioners held their regular scheduled meeting at Wellston City Hall, in recognition of Wellston’s 150th year celebration. Those in attendance were: Wellston Mayor Anthony Brenner, Service Director Staley Camp and Fire Chief Ryan Pelliter, JCEDP Director Sam Brady, as well as staff John Stabler, Jennifer Jacobs and Amanda Williams, Auditor Ridgeway, Wellston Administrator Mindy Eisnagle and Alex Shope with the Telegram. Commissioner Haller read from the pages of the history book written by local Historian Robert Ervin, which stated that on November 12, 1873, Founder Harvey Wells purchases 1000 acres @ \$100/acre from H.S. Bundy, with plans to build several furnaces and lay out a large town in the spring of 1874. A proclamation from the commissioners was read, which stated, in part how Wellston had gone through many industrial cycles over the last 150 years, which included coal mining, iron ore furnaces, textile manufacturing, transportation and frozen food manufacturing. Both Commissioner Willis and Commissioner Hensler congratulated Mayor Brenner and the others for their hard work and dedication in moving Wellston forward. Mayor Brenner stated they are making strides in many areas, specifically the Aerosol plant and BCR expansions.

Director Kelli Johnson with Senator J.D. Vance’s office stopped by with a proclamation congratulating the Mayor and the citizens of Wellston, OH for their accomplishments during this celebration of the past 150 years.
