**Greg Wilkett,(CEO) Tim Poe(Director of Nuclear Operations) and Shawn Jordan (Public Relations) with Fluor BWXT Portsmouth**, were present to give updates regarding the Gaseous Diffusion plant in Piketon, Ohio. Mr. Wilkett stated he was happy to report there were no omissions with the previous project in which they took down the first process building, which was a huge success. They are gearing up for the 2024 construction season, which involves cleaning up this site, which is paving the way for the next process building. They are estimating adding approximately 300 jobs in the construction of the new process building, which will take 4-5 years to complete. Tim Poe stated that economic growth is a priority, and Fluor BWXT has contributed greatly to Jackson County over the years, which has benefited Speyside, Bellisios and the Airport, just to name a few. Fluor BWXT has put \$100 million dollars back into the 4 surrounding counties. The Commissioners and Jennifer Jacobs with JCEDP stated they have appreciated Fluor's support over the past 13 years, and look forward to their continued partnership.
