Motion by Willis second by Haller to approve the meeting minutes of July 17, 2024.

John Haseley (Board Member of Trillium H2 Power), Wiley Rhodes (Co-Founder of Trillium H2 Power) and Caitlin Holley (Vice President of Trillium) were present to discuss the vision of Trillium H2 Power project, which will be located within the grounds of the A-Plant located in Piketon. They have been working with the Department of Energy for the past two years regarding the different phases of this project. Mr. Rhodes stated this is a U.S. first of a kind project that integrates an air separation unit, a partial oxidation reformer to produce hydrogen, an ammonia and silicon plant and a hydrogen power plant, with carbon capture, utilization, and sequestration technology for permanent CO2 geologic storage. This will create approximately 2100 construction jobs and will take 40 months to complete, which then will create 280 long term jobs. Trillium's vision is to use the natural resources that are already here in the United States instead of importing them. They ask the commissioners to consider doing a resolution in support of the project. Commissioner Hensler stated they would review the support letter, but would like to approve it unanimously when Commissioner Haller is present.

Agriculture/Natural Resource Extension Education Joshua Winters, 4-H Youth Development/Educator Maddie Allman and Summer Intern Avery Barker were present to give their updates. Ms. Allman stated they had 544 youth participants enrolled in traditional 4-H programs across 25 community clubs, 150 youth attended 4-H overnight camp at Canter's Cave and 325 youth exhibited a market livestock project and participated in the 2024 Jackson County Jr. Fair Livestock Sale, with 625 market and breeding animals being exhibited this year. (325 went through sale). Ms. Allman stated that the kids have to complete 4-H projects to actually compete in the fair. Ms. Barker (Intern) stated they did a different stem activity each day at the fair (40 attended), focusing on engineering, agriculture, food science, etc....They also partnered with Soil & Water for a day camp – Conservation Day (fishing, soil & water quality, etc...) Mr. Winters stated that in May they held partnered with the Farm Bureau and held Ag day, focusing on dealing with stress and Bio-Day, which all the kids seem to enjoy. In June, they did "Project Book Judging", which encourages the kids to be more knowledgeable about their animals and/or project to actually learn a skill. This has not been enforced regarding livestock in the county for the last several years, so they are getting back to what was required in the beginning and that the State stated was necessary. Farm City Field Day will be September 12, 2024. Mr. Winters had been ask to be a co-moderator at the Farm Science review this year, and the Commissioners congratulated him on the honor.
